Special Notes:

Arizona

Game & Fish Department in 2005 started a program calling for a voluntary ban of lead ammunition in condor range and offers free lead ammunition to hunters in Condor range.

Iowa

S.O.A.R. – Lead in the Environment Advisory Group

Whiterock Conservancy – Requires non-toxic ammunition for all hunting

21 Counties have required non-toxic shot for all hunting (excluding deer and wild turkey) on some of their wildlife management areas

Missouri

March 2007 – lead ammunition is prohibited from all hunting on 21 of its conservation areas

New Hampshire

State law prohibits the use of lead sinkers and jigs in all fresh water in New Hampshire, including lakes, ponds, rivers and streams. The ban prohibits the use of lead sinkers weighing 1 ounce or less and lead jigs less than 1 inch long along their longest axis. The law also prohibits the sale in New Hampshire of lead sinkers weighing 1 ounce or less and lead jigs less than 1 inch long along their longest axis.

New York

Dept. of Environmental Conservation – 464 Environmental conservation officers & forest rangers are switching to non-toxic ammunition – due to public health & environmental concerns

South Dakota

Non toxic shot for small game hunting on:

Game Production Areas

State Parks & Recreation Areas & Lakeside use areas

US Army Corps of Engineers Land

Bureau of Reclamation Land Managed by Game, Fish, & Parks

Shotgun target shooting with lead is prohibited on the following public lands:

Washington

Skagit County & 10 Department of Fish and Wildlife owned lands where pheasants are released – non-toxic ammunition required

Peregrine Fund

Hosted a conference May 2008 on “Ingestion of Lead from Spent Ammunition: Implications for Wildlife and Humans”

Yellowstone National Park - Fishing tackle must be non-toxic. Lead split-shot sinkers, soft lead-weighted ribbon for nymph fishing & other toxic tackle not allowed.
